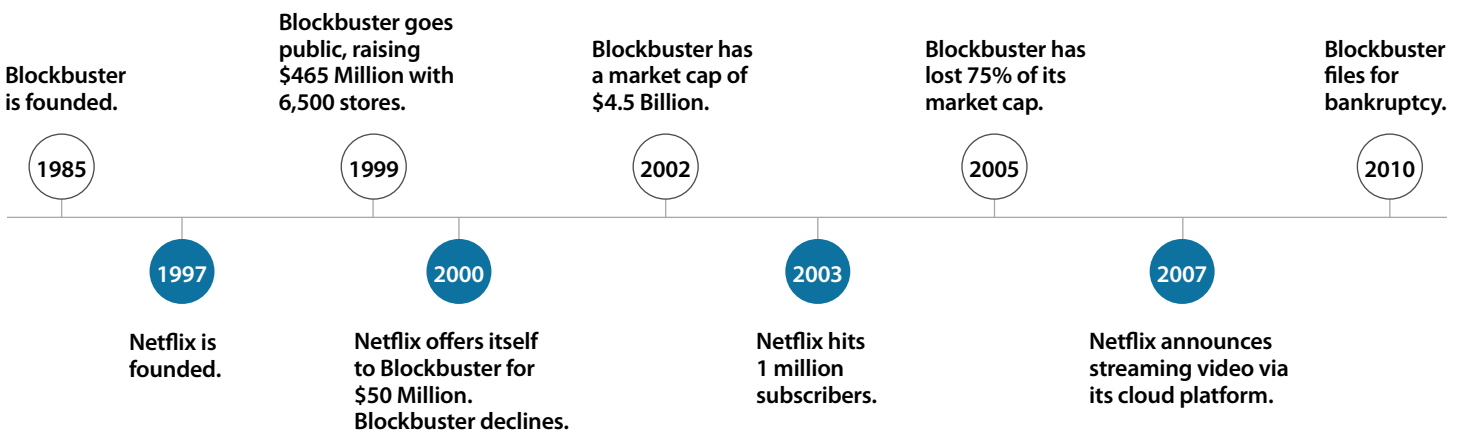


What is Thematic Investing?

Thematic investing aims to provide investors with exposure to secular trends taking shape within the global economy. Such trends may impact industries and influence how they do business. As a result, companies leading the disruption of the status quo may provide significant growth opportunities for investors.

For example, within the thematic category of disruptive technology, Netflix is a great example of a company that replaced an existing digital distribution platform.



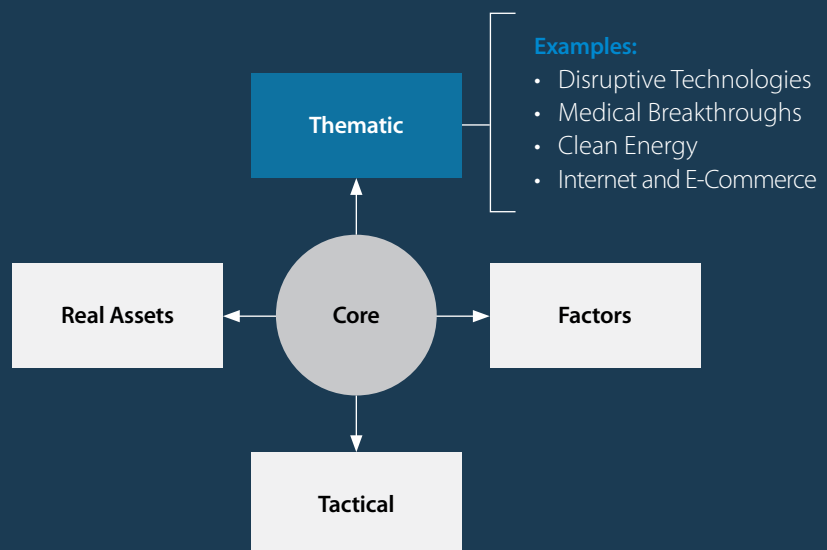

Why Use Thematic Exchange-Traded Funds (ETFs) in a Portfolio?

- An opportunity to add value outside of traditional style box investing.
- To align your beliefs with your investments.
- To add alpha around the core of the portfolio (i.e. as a satellite or complement to the core).

How to Use Thematic ETFs in a Portfolio?

- As part of the growth equity sleeve to capture innovation.
- As a stock replacement story to add diversification.

Ticker: DTEC

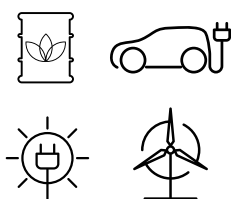
Exposure to 10 different disruptive technology themes with 10 global, pure-play companies within each theme.

Ticker: ACES

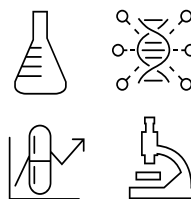
Exposure to US and Canadian-listed pure-play companies that derive a majority of their value from a clean energy business.

Ticker: SBIO

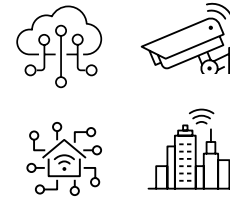
Exposure to US small and mid cap biotechnology companies that are at the forefront of drug development and innovation.

Exposure to some of the largest global companies that derive most of their revenue from the internet technology and e-commerce business segments that exhibit above average growth potential.



Thematic ETFs

- Low overlap to an equity core (S&P 500)
- Low overlap to each other
- High conviction portfolios with purpose
- Pure play holdings to maximize exposure

S&P 500 Index: widely regarded as the best single gauge of large-cap US equities. The index includes 500 leading companies and covers approximately 80% of available market capitalization. One may not invest directly in an index.
